Have you thought of being on the board for NMCA? The Nominating Committee will be seeking nominations for several positions that are coming up in March 2022. # NEBRASKA MUNICIPAL CLERKS ASSOCIATION - EXECUTIVE BOARD MEETING MINUTES VIA ZOOM - OCT. 6, 2021

The Nebraska Municipal Clerks Association Executive Board met via Zoom on Oct. 6, 2021. President Linda Jensen of Central City called the meeting to order at 9 a.m.

ATTENDING: President Linda Jensen of Central City, 2<sup>nd</sup> Vice President Elizabeth Butler of Omaha,

Secretary/Treasurer Erin Saathoff of Beatrice, District 1 Director Janine Schmidt of Morrill, District 3 Director Raquel Felzien of Franklin, District 5 Director Tammy Tisdall of Gretna,

and Ellen Freeman-Wakefield of UNO.

**ABSENT:** 1st Vice President Wendy McKain of Trenton, Past President RaNae Edwards of Grand Island,

District 2 Director Kandra Kinne of Cambridge, and District 4 Director Denise Petersen of

Ponca.

**CONSIDERATION OF APPROVAL OF THE MINUTES FROM THE JUNE 21, 2021 EXECUTIVE BOARD MEETING HELD VIA ZOOM:** Moved by Janine Schmidt of Morrill, seconded by Tammy Tisdall of Gretna, to approve the minutes of the June 21, 2021 Executive Board meeting. VOTE: Ayes – All; Nays – None. MOTION CARRIED.

**APPROVAL OF TREASURER'S REPORT:** Secretary/Treasurer Erin Saathoff of Beatrice reported to the Board as of Aug. 31, 2021, the account balance is \$56,456.82 and CD balance is \$50,000. Moved by Raquel Felzien of Franklin, seconded by Janine Schmidt of Morrill, that the Treasurer's Report be approved. VOTE: Ayes – All; Nays – None. MOTION CARRIED.

**DISCUSSION ON THE CLERKS' INSTITUTE AND ACADEMY FOR MARCH 2022:** Ellen Freeman-Wakefield reported to the board that registration will open Nov. 1 and the fees will remain the same as in the past. Freeman-Wakefield did note that the fees may need to be increased in the future. Freeman-Wakefield and Tammy Tisdall of Gretna, will be traveling to Grand Island Friday to view the hotel. Some topics that will be offered during the Institute and Academy include: Disabilities Training, Records Retention, Code Enforcement, Tax filing, Roberts Rules of Order, Utility Billing, and Risk Management. Freeman-Wakefield stated she has made some changes to the structure of the Institute and Academy. The Annual Meeting will be held Thursday morning during breakfast and Round Tables will be held Thursday afternoon. The banquet will begin at 6:30 p.m., with social hour starting at 6 p.m. There will be a networking luncheon on Monday and Wednesday evening, from 5 p.m. to 7 p.m., the vendor recognition networking event will be held.

**EXECUTIVE BOARD MEETING AT THE MARCH NMCA INSTITUTE AND ACADEMY:** President Linda Jensen of Central City, inquired if there was a time reserved for the board meeting and Freeman-Wakefield stated there is not, however, suggested that the meeting could be held on Thursday during the association luncheons. Members present were in favor of holding the meeting during that time. Jensen inquired if lunch could be brought in for the boardmembers and Freeman-Wakefield stated she would check into that possibility.

**IIMC BID FOR IIMC CONFERENCE IN OMAHA IN 2026:** 2<sup>nd</sup> Vice President Elizabeth Butler of Omaha and Ellen Freeman-Wakefield of UNO, met with International Institute of Municipal Clerks' (IIMC) representatives and Butler stated she feels Omaha has a good chance of being selected. Butler noted IIMC inquired if the NMCA Institute and Academy in 2026 will be cancelled. Butler explained that Omaha has a better chance if the association will make a donation to the conference. Freeman-Wakefield stated the IIMC Board will be making a decision on Friday. Butler noted the Omaha Visitors Bureau will make a contribu-

tion of \$40,000. Freeman-Wakefield noted IIMC wants to see a commitment made prior to making their decision. Freeman-Wakefield stated UNO will still do a Mini Clerk School, similar to the one (1) that was held in 2016 when the IIMC Conference was in Omaha, which allows for those clerks not wishing to attend the IIMC Conference to receive training. Freeman-Wakefield stated UNO can also contribute some funding to go towards speakers at the event up to approximately \$20,000. Freeman-Wakefield asked Butler to make the notation to IIMC that UNO's donations would be In-Kind Services. President Linda Jensen of Central City entertained a motion be made to proceed with the finalization of the bid.

Moved by Tammy Tisdall of Gretna, seconded by Erin Saathoff of Beatrice, that the Nebraska Municipal Clerks Association proceed with submitting its bid for the IIMC Conference to be held in Omaha in 2026. **VOTE:** Ayes – All; Nays – None. <u>MOTION CARRIED</u>.

Moved by Tammy Tisdall of Gretna, seconded by Eliza Butler of Omaha, to proceed with the issuance of the \$30,000 prepayment to IIMC.

**VOTE:** Ayes – All; Nays – None. <u>MOTION CARRIED</u>.

Moved by Raquel Felzien of Franklin, seconded by Eliza Butler of Omaha, to forego the standard NMCA Institute and Academy in 2026.

**VOTE:** Ayes – All; Nays – None. <u>MOTION CARRIED</u>.

**DISCUSSION ON MEMBERSHIP DUES:** President Linda Jensen of Central City inquired if membership dues should be increased and a motion made at the meeting in March. Elizabeth Butler of Omaha stated she would rather raise the dues in March to allow for some cushion for the possible increase of costs associated with the NMCA Institute and Academy. Tammy Tisdall of Gretna agreed with Butler. Ellen Freeman-Wakefield of UNO stated the increase will not be significant, however, the current registration fees have remained the same for twelve (12) years. Butler inquired what other state associations charge for dues and no one was sure. Jensen stated she would do some research and report back to the board, as well as entertain a motion to increase membership dues at the next meeting. Freeman-Wakefield suggested reaching out to all the states in Region VIII for a good comparison.

**WEDNESDAY NIGHT MEET AND GREET DURING THE NMCA INSITUTE AND ACADEMY IN MARCH 2022:** President Linda Jensen of Central City, stated the vendor hospitality night during the Clerk Institute and Academy in March 2022 will be held Wednesday from 5:30 p.m. to 7 p.m. and asked for volunteers to serve on the committee to plan and organize the event. Raquel Felzien of Franklin stated Erin Saathoff of Beatrice and she have taken over contacting the vendors, since Kelly Oelke of Hickman is no longer on the board. It was suggested by Tammy Tisdall of Gretna that Kandra Kinne of Cambridge and Denise Petersen of Ponca be in charge of organizing the hospitality night. All members present were in favor. Jensen will send out an email notifying them of their appointment to the committee.

**REVIEW OF 2020 NMCA INSTITUTE AND ACADEMY VIA ZOOM:** President Linda Jensen of Central City reported that she felt the virtual conference went well and thanked Ellen Freeman-Wakefield of UNO for all of her work putting the conference together.

**IIMC ANNUAL CONFERENCE IN LITTLE ROCK, ARKANSAS – MAY 22-25, 2022:** President Linda Jensen of Central City reported that the next IIMC Annual Conference will be held in Little Rock, Ark., May 22-25, 2022.
