UPDATE AND DISCUSSION ON THE HOSPITALITY EVENT – 2022: President Linda Jensen of Central City stated the Wednesday Hospitality Event was a well-received event. Jensen noted the bylaws will need to be changed as a result of the vote held during the General Membership meeting this morning, to assign the planning of the annual hospitality event to the 2nd Vice President.

DISCUSSION AND MOTION TO PULL ADDITIONAL FUNDS FOR THE 2022 SCHOLARSHIPS: Ellen Freeman-Wakefield reported to the Board and Officers that Piper Sandler reduced their scholarship contribution amount to \$1,500, instead of \$3,000 as originally promised. District 2 Director Kandra Kinne of Cambridge inquired why they reduced their contribution and Freeman-Wakefield explained they told her they did not have as good of a year as they had hoped. Moved by Wendy McKain of Trenton, seconded by Tammy Tisdall of Gretna, to transfer \$1,500 from the general fund to the scholarship line. **VOTE:** Ayes – All; Nays – None. <u>MOTION CARRIED</u>.

2022 CLERKS INSTITUTE AND ACADEMY REVIEW – ELLEN FREEMAN-WAKEFIELD, UNO: Ellen Freeman-Wakefield of UNO, reported the 2022 NMCA Institute and Academy has gone well so far. Freeman-Wakefield stated she will have to make an adjustment on total credit hours those clerks completing assessments will receive, due to two (2) sessions not filling the required two (2) hours. Freeman-Wakefield stated they will go out for bids for the location of the conference for 2024 and 2025. Freeman-Wakefield also reported there has been some confusion regarding the LB 781 treasurer hour requirement and several clerks have asked for more of those hours to be available during this conference. However, this conference is for municipal clerk training. It was noted that those needing treasurer's hours could receive them during the Municipal Accounting and Finance Conference that is held annually, as well as several other conferences that the League of Nebraska Municipalities puts on.

DISCUSSION AND CONSIDERATION OF PURCHASING NMCA LAPEL PINS: Secretary/Treasurer Erin Saathoff of Beatrice volunteered to order NMCA lapel pins of the new NMCA Logo that was voted on during the General Membership meeting this morning, to be handed out at the IIMC Annual Conference. Remaining lapel pins will be distributed to the NMCA members. A total of \$1,000 has been budgeted.

2023 CLERKS INSTITUTE AND ACADEMY: Ellen Freeman-Wakefield of UNO stated the conference will be held at the Holiday Inn in Kearney, Neb. next year. Freeman-Wakefield plans to change the Thursday Association Luncheon to a lunch on your own, allowing fifteen (15) minutes to the Thursday morning Business Meeting. Freeman-Wakefield stated the Executive Board Meeting will be held over the lunch hour on Thursday, as well. Making these changes will bring the total educational hours to 32.75 for the Institute. Freeman-Wakefield suggested the Vendor Committee invite vendors to attend on an "invite only" once it is determined the number of vendors that will be allowed to attend. Freeman-Wakefield noted the room rate will be \$114/room/night, NMCA will have six (6) suites for speakers, and the food gratuity will be added, with the percentage being somewhere between eighteen percent (18%) to twenty-two percent (22%).

DISCUSSION ON DIVIDING THE NMCA SECRETARY/TREASURER POSITION: President Linda Jensen of Central City stated Secretary/Treasurer Erin Saathoff of Beatrice asked that this item be placed on the agenda for consideration. Saathoff explained that her Area Association has a set Treasurer position which works well. Saathoff noted in her position she does not handle finances and it may be best to have someone more consistent in the position rather than having a constant turnover. Saathoff also stated this would offer an additional leadership position for those interested. 2nd Vice President Eliza Butler of Omaha stated she would support this change. District 2 Director Kandra Kinne of Cambridge suggested setting a five (5) year term for the treasurer's position. Past President RaNae Edwards of Grand Island inquired what would happen if the person in the treasurer's position was not doing an acceptable job. District 5 Director Tammy Tisdall of Gretna suggested adding a

clause in the by-laws that would allow the Board and Officers to appoint a new person if the job is not being performed sufficiently. This item will be brought to a future General Session meeting for consideration.
